For end of each quarter, they will be disclosed in the quarterly financial announcement.

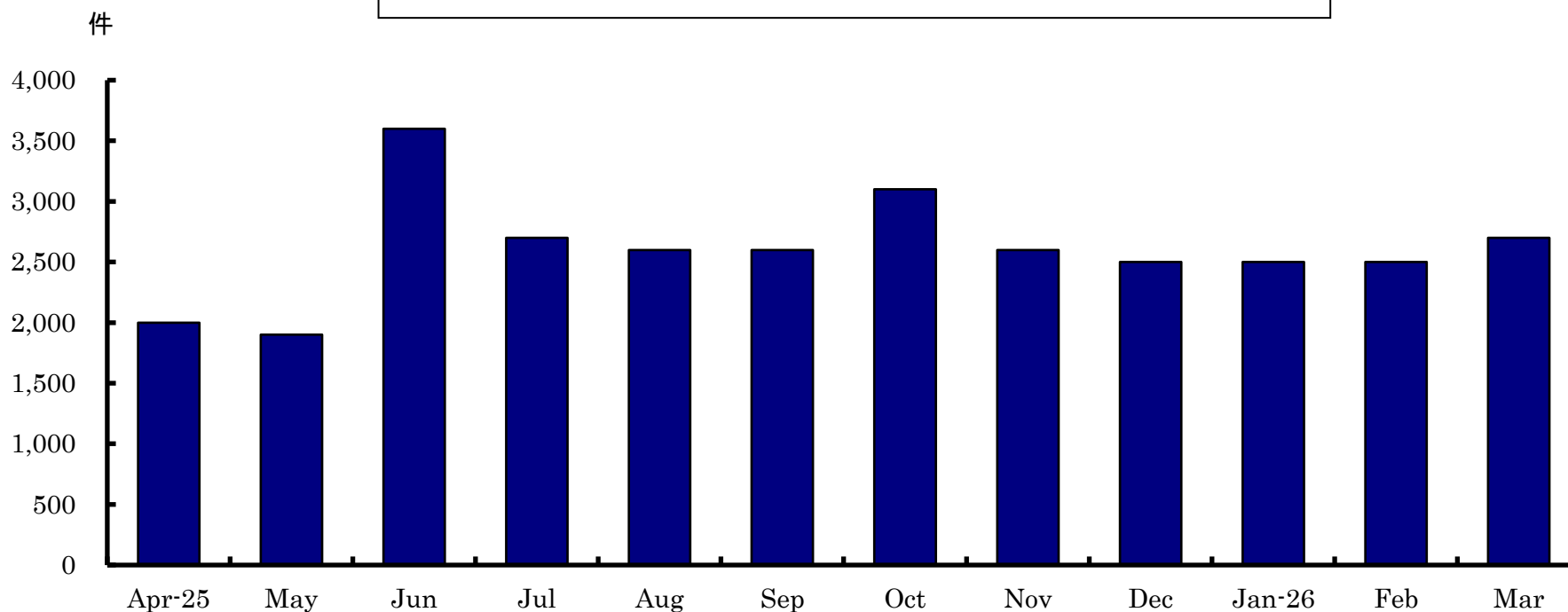
